

SUMMARY ANNUAL REPORT FOR RIVER VALLEY CHILD DEVELOPMENT 403(B) DC PLAN

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the RIVER VALLEY CHILD DEVELOPMENT 403(B) DC PLAN, EIN 55-0706025, Plan 001, for period July 1, 2023 through June 30, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, total participant-directed account, Code section 401(m), Code section 403(b)(7), single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$208,013. These expenses included \$2,807 in administrative expenses and \$205,206 in benefits paid to participants and beneficiaries. A total of 303 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$6,412,358 as of June 30, 2024, compared to \$5,218,076 as of July 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$1,194,282. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,402,295, including employer contributions of \$298,686, employee contributions of \$375,849, other contributions of \$22,515, earnings from investments of \$51,954 and other income of \$653,291.
